

GREATER GOOD CHARITIES “FEED THY NEIGHBOR” SWEEPSTAKES

- OFFICIAL RULES -

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR DONATION OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL ENTRIES FOLLOWING THE RULES HAVE AN EQUAL CHANCE OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. PROMOTION DESCRIPTION: Greater Good Charities’ “Feed Thy Neighbor” End-of-Year charitable campaign ("Sweepstakes") begins on 17 December 2020 at 12:00 pm PST and ends on 29 December 2020 at 5pm PST (the "Promotion Period").

The Sweepstakes’ Goal is to generate donations benefiting our neighbors in these times of need. Sweepstakes entry can be made with or without a donation. Regardless of entry type, all entries will be eligible to win, through a random drawing, one of 5 prize opportunities to join a virtual meet and greet with Chris Pratt and designate a grant of up to \$10,000 to a food bank in the winner’s area. While entry is free, Greater Good Charities appreciates all voluntary donations made, if any, at time of entry.

2. PROMOTION ENTRY RULES:

Sweepstakes’ participants may submit multiple entries by making a donation, by completing the alternative method of entry form, or by a combination of these two methods. **TO ENSURE EQUAL ODDS OF A WINNING ENTRY, PLEASE READ AND FOLLOW THESE ENTRY RULES CAREFULLY.**

- a. **Entry by Donation:** For each one (\$1) US dollar donated, up to the first one thousand (\$1000) dollars, the Entrant receives one “Entry” per dollar donated. The Entrant may donate any amount to the campaign but the maximum number of Entrant’s “Entries” will be capped at one thousand (1000) for the purposes of the random drawing. An Entrant may donate as often and as much as they desire.
- b. **Entry by Alternative Means:** Entrants may enter the sweepstakes free and without donation. Each “Entry” by alternative means will constitute two hundred fifty (250) “Entries” in the Entrant’s name. Entrants may enter as often as they desire but only the first four (4) “Entries” will be credited for a maximum of one thousand (1000) “Entries”.

- c. **Entry by a Combination of Means:** Entrants may both donate some amount less than one thousand (\$1000) dollars and submit additional “Entries” by alternative means in order to accumulate the maximum one thousand (1000) “Entries” for the random drawing.
- d. **Maximum Number of Entries Purpose:** Participants’ “Entries” are capped at one thousand (1000) in order to provide for an equal probability of winning in a randomly selected sample. An Entrant may choose to participate with fewer than one thousand (1000) “Entries” but they do so accepting that their odds of winning will be unequal and less than those submitting one thousand (1000) “Entries”. ALL PARTICIPANTS ARE ENCOURAGED TO SUBMIT THE MAXIMUM NUMBER OF “ENTRIES” PERMITTED.

The primary sponsor of this Sweepstakes is Greater Good Charities ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Additional co-sponsors are participating in this Sweepstakes as providers of prizes. Sponsor, with the assistance of the co-sponsors, is responsible for the collection, submission or processing of Entries and the overall administration of the Sweepstakes. 3. **ELIGIBILITY:** The Sweepstakes are open to all US Citizens and Permanent Residents, eighteen (18) years of age or older (the "Entrant") in those US States which the terms and conditions of the Sweepstakes are legal. Sponsor, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees (the "Promotion Entities"), are ineligible to enter the Sweepstakes or win a prize. Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. "Household Members" shall mean those people who share the same residence at least three months a year. "Immediate Family Members" shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. This Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.

4. PRIZE(S):

Five (5) PRIZE winning Entrants (“Winners”) will receive the opportunity to join Chris Pratt in a virtual meet and greet via Zoom for up to 10 minutes. Winners will also receive the ability to designate a grant of up to \$10,000 to a food bank of their choice, provided the food bank meets Greater Good Charities’ granting requirements. Winners will also be recognized by Chris Pratt on a live Instagram telethon on New Year’s Eve. These PRIZES represent a once in a lifetime opportunity to participate in a historic fundraising event.

One (1) additional PRIZE winner will be personally recognized by Chris Pratt as the top donor to this wonderful End-of-Year campaign.

There is no individual and/or aggregate average (“ARV”) retail value associated with the Prizes. The ARV of all Prizes represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed.

PRIZES cannot be transferred, redeemed for cash, rescheduled or substituted by winner. Given the nature of each PRIZE, no PRIZE can be awarded after the end of the Sweepstakes event. Restrictions, conditions, and limitations may apply to the PRIZE.

Automated or robotic Entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. The Entrant may make any number of Entries, either free or accompanied by a donation during the Promotion Period. Any attempt by Entrant to make more than the number of legitimate direct Entries allowed above by using multiple/different email addresses, identities, registrations, logins or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void Entrant's Entries and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to eligibility verification as set forth below. All Entries must be posted by the end of the Promotion Period in order to participate. Sponsor's database clock will be the official timekeeper for this Sweepstakes.

6. WINNER SELECTION: The Winner(s) of the Sweepstakes will be selected in a random drawing from among all eligible Entries received throughout the Promotion Period. ALL VALID ENTRIES FOLLOWING THE RULES IN SECTION 2 SHALL HAVE AN EQUAL CHANCE OF WINNING. The random drawing will be conducted on 29 December 2020 at 6pm PST after the Promotion Period by Sponsor or its designated representatives, whose decisions are final. Odds of winning will vary depending on the number of eligible Entries received but all Entries shall have an equal chance of winning if the Entrant has chosen to submit the maximum number of “Entries” permitted.

7. WINNER NOTIFICATION: Winners will be notified by email and telephone at the email address and phone number provided in the Entry Information by 7pm PST. Potential Winners must accept a prize by email as directed by Sponsor by 9am PST on 30 December. Sponsor is not responsible for any delay or failure to receive notification for any reason, including inactive

email account(s), technical difficulties associated therewith, or Winner's failure to adequately monitor any email account.

Any winner notification not responded to or returned as undeliverable may result in prize forfeiture and re-award of the Prize. The potential prize winner will be required to sign and return an affidavit of eligibility and release of liability, and a Publicity Release (collectively "the Prize Claim Documents"). No substitution or transfer of a prize is permitted except by Sponsor.
